SFBGS OPERATES THE GARDEN BOOKSTORE AND GIFT SHOP AND MANAGES ALL COMMUNITY OUTREACH EFFORTS ON BEHALF OF THE GARDEN. PROGRAM SERVICE REVENUE INCLUDES BOOKSTORE/GIFT SHOP SALES AND ADMISSIONS INCOME. ADMISSIONS INCOME FROM NON-RESIDENTS IS COMPRISED OF REIMBURSED COSTS TO OPERATE THE PROGRAM, AS WELL AS AN ALLOCATION OF THE GARDEN'S ADMISSIONS RECEIPTS. TOTAL ADMISSIONS RECEIPTS IN FISCAL YEAR 2022 WERE \$1,824,435, ALL OF WHICH SUPPORTS GARDEN IMPROVEMENTS AND PROGRAMS.
